Sir/Madam,

Considering the approval issued by Government of Maharashtra vide its resolution stated in ref. no. 1 & NOC of Regional Jt. Director office ref. as no. 2, the competent authority of the University has decided to grant **First Time Affiliation subject to compliance of discrepancies** to run following programmes from the academic year 2024-2025, in accordance with the provisions of Section 109 of the Maharashtra Public Universities Act, 2016, UGC guidelines, and University prevailing norms as stated below:-

1. The college concerned should not admit students beyond the intake capacity approved by the University,
2. The college on completion of 5 years have to apply for NAAC accreditation within one year, failing which, their affiliation will automatically stand cancelled.
3. College shall apply for Academic & Administrative Audit on completion of 3 years.
4. You are requested to inform to the University whether you have started the above course during the academic year 2024-25 and number of students admitted to the said course.

5. The College shall maintain the rosters for reservation of posts of teaching and non-teaching staff, as per the reservation policy of the concern State Government and maintain service books and the provident fund registers of all employees
6. That the college shall comply with the conditions laid down by the concerned State Government with respect to student's admissions belonging to SC/ST/DT/NT/OBC etc categories i.e. observing constitutional social & reservation policy of the State in which the college is conducted.
7. Only women candidate to be admitted to the said programme in the Institute.
8. The Institute is required to apply for continuation of affiliation of recognition every year in the month of **September** in prescribed performa alongwith affiliation fee.
9. That the College shall comply with the Orders/directives issued by the Chancellor, the Vice Chancellor and other officers of this University in exercise of the powers conferred on them under the provisions of the Act, Statutes, Ordinances, Rules and Regulations
10. That the College shall send to the University, the progress reports of the compliance of the above conditions from time to time.
11. The conditions of First Time Affiliation and the observations stipulated by the Local Inquiry Committee shall also be complied with by the Trust/Sanstha/Mandal/Society within the given time limit.
12. On receipt of First Time Affiliation letter, the College concerned should apply for,
 - a. Syllabus and fee structure to Academic Section on (email id - academics@sndt.ac.in & Contact No - 022-22036885)
 - b. Also, registered college on University admission online portal (email id - dusndt@mkcl.org & Contact No - 022-26608304)
 - c. Also, registered college on Affiliation portal (for technical support you may contact on 8828996661/ 8828996662 during office hours)
 - d. On receipt of Affiliation letter the college administration, a new email ID should be generated by including **the college code** and communicated to the Affiliation Section. So that it is convenient for Affiliation Section to conduct all further correspondence on the same email.

As per the UGC Regulation the Trust has to fulfill the following conditions:-

1. The administrative, academic and other buildings with sufficient accommodation to meet the immediate academic and other pace requirements as specified by the University concerned for each of the higher education course/ programme with adequate scope for

2. future expansion in conformity with those prescribed by the UGC/ Statutory/ Regulatory body concerned, taking care that all buildings constructed in the college are disabled friendly,
3. The academic building sufficient to accommodate the faculties, lecture/seminar rooms, library and laboratories with a minimum of 15 sq.ft. per student in lecture/seminar rooms/library and 20 sq.ft. per student in each of the laboratories,
4. The Sanstha shall appoint the number of teaching and non-teaching staff required as per prevailing norms. And approval seeks to the faculty thus appointed from the University.
5. The adequate civic facilities for essentials like water, electricity, ventilation, toilets, sewerage etc in conformity with the norms laid down by the Central/State PWD,
6. The library with at least 500 books, or 100 books in different titles on each subject, whichever is more, of the proposed programmes to include both text books and reference books, besides two journals per subject, along with a book bank facility for students belonging to other Schedule Castes, Scheduled Tribes and such other sections as may be specified by the UGC from time to time,
7. Necessary laboratory equipments as prescribed by the University /Statutory/Regulatory body concerned, for each of the higher education programmes,
8. The multi-purpose complex/an auditorium and facilities for sports, canteen, health care, separate rooms and separate hostels for boys and girls as per the local requirements as decided by the University,
9. The appropriate furniture for lecture/seminar rooms, laboratories, library, faculty rooms, rooms for administrative staff including the Principal, multi-purpose complex /auditorium, common rooms and hostels rooms, and other facilities,
10. The College shall satisfy the University that adequate financial provision is available for running the college for at least three years, without any aid from any external source. In particular, it shall produce evidence of creating and maintaining a Corpus Fund permanently in the name of the college by way of irrevocable Government Securities of Rs.35 lakh per programme as you will be starting to offer professional programme, or FDRs for like amounts jointly held by the college and the University for a minimum lock in period of three years. The interest accrued out of it may be utilized

by the college with the prior permission of the University for strengthening its infrastructure facilities,

11. The College shall also provide an undertaking to the University that it has adequate recurring income from its own resources for its continued and efficient functioning,

The Sanstha shall give an undertaking on stamp paper worth Rs. 100/- wherein it will agree to comply with all the conditions for affiliation as states above and also agree to abide by the rules and regulations as may be framed by the University from time to time.

NOTE: This approval is subject to rectification of discrepancies within 6 months, if College Management is fails to comply, the approval issued will be automatically stand revoked.
